# **3. SUSTAINABILITY POLICY**

### 1. STRATEGY AND POLICY STATEMENT:

#### A. <u>Procurement</u>

(f) Be ethical in all aspects of our dealings with our supply chain as per our statements and policies.

(g) Encourage a focus on and continuous improvement of sustainable alternatives throughout our supply chain.

# B. Community

(a) Work as a considerate infra company within local communities, build relationships and seek to integrate with the neighbourhood and its environs.

(b) Achieve harmonious and effective relationships in all interactions with local communities.

(c) Where possible, support the local community and its businesses by sourcing local goods and services, including the recruitment of local personnel.

## C. Climate and Natural Resources

(a) Manage our carbon emissions in line with our ESG strategy using renewables and alternative technologies to decarbonise our works.

(b) Select energy suppliers from renewable sources where available and use alternative fuels and renewable energy.

(c) Work with our project consultants and waste management contractors to divert material away from landfill and to focus on resource material management planning and the circular economy.

(a) Provide sufficient information, advice, training and supervision in relation to environmental sustainability to ensure that all persons working for or on behalf of Ceigall India Limited are aware of their responsibilities and are competent to undertake their activities in a constructive manner.

(b) Consult with all relevant parties to improve environmental sustainability and to reduce carbon in the Indian Infrastructure sector.

(c) Continue to fulfil our Equality, Diversity and Inclusion commitments.

(d) Support work life balance alternatives and our Wellness Strategy for all employees of the company.

(e) Ensure that our work areas are safe places of work for our employees, contractors, supply chain, visitors and neighbours.
